

# ELECTIONS TO THE EUROPEAN PARLIAMENT FROM THE 9<sup>TH</sup> JUNE 2024

## Postal Vote

Eligible for a postal vote are:

1. All Europeans on the electoral roll who are at least 18 years old on election day;
2. Luxembourgers residing abroad.

The application can be made either by a simple letter, a pre-printed form or via the platform **www.myguichet.lu**. The application must be sent to the College of Aldermen of the commune in which one resides.

The application of a **Luxembourgish citizen resident abroad** must be sent to the municipality of the last residence in the Grand Duchy, otherwise to the municipality of the place of birth in the Grand Duchy otherwise to the City of Luxembourg. The applicant must provide a **copy of his valid Luxembourgish passport or identity card**.

## Deadlines

### If the voting form is sent to an address in Luxembourg:

The application must reach the College of Aldermen otherwise forfeited, no earlier than Monday, **18<sup>th</sup> of March 2024** and no later than Wednesday, **15<sup>th</sup> of May 2024**.

The voting form will be sent to addresses in Luxembourg at the latest on **25<sup>th</sup> of May 2024**.

### If the voting form is sent to an address abroad:

The application must reach the College of Aldermen otherwise forfeited, no earlier than Monday, **18<sup>th</sup> of March 2024** and no later than Tuesday, **30<sup>th</sup> of April 2024**.

The voting form will be sent to addresses abroad at the latest on **10<sup>th</sup> of May 2024**.
