However, whether or not subsidies are awarded is subject to certain conditions. The benefits and the rules that underpin them are also regularly updated. People are often unaware of what, when and how to claim. That is why we are publishing this practical guide. It summarises the awards currently offered by our commune and the private sector in all areas of daily life and will give you a quick and clear overview of all the support on offer.

# Benefits offered by the commune

The Mamer commune may, on certain conditions, grant subsidies to support its residents with various aspects of daily life.

# ENVIRONMENT

Mindful of the need to protect the environment, the commune encourages residents to use energy in a rational way and to invest in facilities that promote the use of renewable energy.

# Transformation of a gravel garden into a green area in front of buildings

Subsidies offered by the commune: Rate: € 100/m<sup>2</sup> Cap: €1,000

#### Conditions:

- The regulation in question is applicable for any works made after January 1, 2023.
- Be resident in the municipality of Mamer.
- The application must be submitted before the works start.

Documents to be included (before the works):

• a picture of the current situation.

## Documents to be included (after the works):

- a picture of the situation,
- a copy of the original invoice(s).

# Subsidies for the rational use of energy and the development of renewable energies

Subsidies offered by the commune: Rate: 30% Cap: €7.200

- Be resident in the municipality of Mamer.
- The home must be located within the Mamer commune.
- The subsidy may only be granted once per facility and per site.
- Applicants must have benefited from an equivalent subsidy from the State.
- You will need to apply to the commune within one year of the date of the State's letter awarding a subsidy.





# Installation of rainwater harvesting equipment

# System serving a single residence (state financial support)

Subsidies offered by the commune: Rate: 100% Cap: €1,000


Conditions:

- The applicant must have benefited from an equivalent subsidy granted by the State.
- Be resident in the municipality of Mamer.

# System serving a group of residences (state financial support)

Subsidies offered by the commune: Rate: 50% Cap: €500/residence

- You must have obtained a state subsidy to install equipment.
- Be resident in the municipality of Mamer.





The commune of Mamer supports young people aged 18 who want to explore Europe by train. It also offersseveral subsidies to promote zero or low  $CO_2$  emission vehicles.

# Purchase of an "InterRail" ticket for 18-year-olds

#### Subsidies offered by the commune:

Rate: 90% Cap: 500€

## Conditions:

- Be resident in the municipality of Mamer.
- Must be 18 on the day of purchase of the ticket.
- The financial contribution applies to all the formulas offered by the "InterRail" programme.
- The request must be submitted no later than one year after activation of the ticket.

## Documents to be included:

- a copy of the ticket,
- a copy of the paid invoice or proof of payment,
- a proof that the ticket has been activated.



# Purchase of a new bicycle or a new cycle with pedal assistance

#### Subsidies offered by the commune:

Rate: 25% of the amount allocated by the State Cap: 300€

# Conditions:

- The regulation in question is applicable for any request made after April 1, 2022.
- Be eligible for financial assistance allocated by the State.
- Be resident in the municipality of Mamer.
- Not having benefited from this municipal subsidy within 5 years of the said request.
- The application for municipal subsidy must be submitted within 1 year following the decision to allocate financial aid by the State.

#### Documents to be included:

- a copy of the paid invoice,
- a copy of the decision relating to the allocation of financial assistance.



# Installation of private charging stations for electric vehicles

#### Subsidies offered by the commune:

Rate: 50% of the amount allocated by the State Cap: 600€

## Conditions:

- The regulation in question is applicable for any request made after April 1, 2022.
- Be resident in the municipality of Mamer.
- Be eligible for financial assistance allocated by the State.
- Not having benefited from this municipal subsidy within 5 years of the said request.

Documents to be included:

- a copy of the paid invoice,
- a copy of the decision relating to the allocation of financial assistance.

# **Road vehicles**

#### Subsidies offered by the commune:

Rate: 10% of the amount allocated by the State Cap: 600€

# Conditions:

- The regulation in question is applicable for any request made after April 1, 2022.
- Be resident in the municipality of Mamer.
- Be eligible for financial assistance allocated by the State.
- Not having benefited from this municipal subsidy within 5 years of the said request.

## Documents to be included:

- a copy of the registration certificate,
- a copy of the decision relating to the allocation of financial assistance.



# "Long-term" subscription to the vel'OH! service

# The commune will reimburse the costs of a "long-term" subscription to the vel'OH! bicycle rental service.

Subsidies offered by the commune:

Rate: 100%

Amount: the cost of a "long-term" subscription

- Be resident in the municipality of Mamer.
- The application must be made within one year of the invoice date.







Support is available for owners, leaseholders or purchasers of property within the Mamer commune. Domestic rainwater harvesting is also encouraged.

# Housing construction or purchase

# Support with housing construction or purchase

Subsidies offered by the commune: Rate: 50% of the state subsidy Cap: €743.68

Conditions:

- You must have received a grant from the State to purchase or build housing, known as a "prime d'acquisition ou de construction".
- Be resident in the municipality of Mamer.
- You must live in the property yourself for at least ten years.

# Interest subsidy scheme with a view to housing construction, purchase or development

Interest subsidy scheme with a view to housing construction, purchase or development Subsidies offered by the commune:

Rate: 100% of the state subsidy Cap: €600

- You must also benefit from an interest subsidy from the State of more than €25 per reference year.
- Be resident in the municipality of Mamer.
- You must live in the property yourself for at least ten years.



# Renovation of listed buildings

Subsidy for restoration works and the improvement of buildings of historical, architectural, artistic, industrial, scientific or technical interest Subsidies offered by the commune: Rate: 25% Cap: €10,000/building

- Be resident in the municipality of Mamer (applicants may be natural or legal persons).
- Applicants must notify the commune of their intention to complete works giving rise to the subsidy from the commune.
- The application for the subsidy must be filed with the commune when the works are completed and no later than 3 months after receipt of a document showing the amount of any subsidies received from the State.
- You will need to supply proof of payment of the subsidies from the National Sites and Monuments Department (SSMN).
- You will also need to supply the invoice for the completed work.



# SOCIAL SUPPORT PROGRAMMES

The Mamer commune cares about its residents' well-being. As a result, it lends its support to early-years initiatives as well as those for vulnerable individuals.

# Users of the Krank Kanner Doheem Service (KKDS)

# Grant for users of the Krank Kanner Doheem Service (KKDS) Subsidies offered by the commune:

Rate: 50% Annual cap: €150/child

Conditions:

- The unwell child must be in pre-primary or primary education (up to age 11). If the child attends a school outside the Mamer commune, you will need to supply a certificate of school attendance.
- You will need to supply a paid invoice issued by the KKDS.
- The application must be made no later than 3 months after the KKDS invoice date.

# Disposal of baby nappies

# Grant for the disposal of baby nappies Subsidies offered by the commune: Rate: €4/month

Annual cap: €48/year

- Be resident in the municipality of Mamer.
- The children concerned must be less than three years old.
- The application must be made before 31 December of the current year.



# Use of washable nappies

## Grant to rent washable nappies

Subsidies offered by the commune: Rate: -Cap: €55/child

Conditions:

- Be resident in the municipality of Mamer.
- The children concerned must be less than three years old.
- The application must be submitted before 31 December of the current year.

#### Grant to purchase washable nappies

Subsidies offered by the commune: Rate: -

Annual cap: €100/child

# Conditions:

- Minimum amount of €300 (annual subsidy).
- Be resident in the municipality of Mamer.
- The children concerned must be less than three years old.
- You will need to reapply once a year.
- The application must be submitted before 31 December of the current year.

# People with incontinence

# Grant for people with incontinence Subsidies offered by the commune: Rate: -Annual cap: €100/person

#### Conditions:

- Be resident in the municipality of Mamer.
- When the first application is made, the applicant must provide a medical certificate demonstrating that the relevant person has incontinence.

# Snow clearance and hedge trimming

## Subsidy for snow clearance and hedge trimming

Subsidies offered by the commune: Rate: €10/hr Annual cap: €250

- Be resident in the municipality of Mamer.
- The subsidy is available to individuals who are at least 65 years old (whether they live alone or as part of a couple) and to other dependent people of any age.
- The application must be submitted before 1 March of the year following that in respect of which the subsidy is due.
- This only relates to the trimming of roadside hedges and the clearing of snow from, and gritting of, pavements and pedestrian access to houses.



# Cost of living allowance and energy premium

Subsidies offered by the commune: Rate: 20%

Annual cap: €750

- Be resident in the municipality of Mamer.
- The application must be submitted no later than 15 March of the year following that to which the subsidy relates.
- A supporting document from the National Solidarity Fund, indicating the amount of the cost-of-living allowance and the energy premium received by the applicant for the reference year.
- The cost-of-living allowance and the energy premium can be combined with other allowances or aids granted by the State, the social office or other institutions.
- You will need to reapply once a year.



# Extra-curricular support for dysgraphic and dyslexic children

# Contribution towards the registration fees for students attending courses delivered by the non-profit association SOS-LRS

Subsidies offered by the commune:

• The subsidy from the commune covers up to one third of the course registration fees.

#### Conditions:

• The applicant and the student must be resident within the Mamer commune.



# **EDUCATION**

Education is of the utmost importance to the Mamer commune. The most disadvantaged students will be granted financial support to incentivise and encourage them to succeed at school. All students in secondary school and beyond also benefit from financial support as long as they have not repeated the school year.

# Grant for disadvantaged students

#### **Disadvantaged students**

Subsidies offered by the commune:

• Support from the commune equal to the subsidy granted by the National Education Ministry's welfare department.

- Be resident in the municipality of Mamer.
- Documentary evidence that the subsidy has been granted by the National Education Ministry's welfare department must be supplied.
- The student must be in post-primary education.



# Subsidy/incentive for pupils, apprentices and students

From the 7th to 5th grades of general secondary education or S1-S3 Subsidies offered by the commune: Rate: -Annual cap: €100

From the 4th to 2nd grades of general secondary education or S4-S6 Subsidies offered by the commune: Rate: -Annual cap: €125

The first grade of general secondary education or S7 Subsidies offered by the commune: Rate: -Annual cap: €175

Higher and further education (including non-university study) Subsidies offered by the commune: Rate: -Annual cap: €200

- Be resident in the municipality of Mamer.
- You must have passed the school year.
- You must not have failed your course.
- You must not choose a lower level of education.





# Private sector benefits

Residents of the Mamer commune may also benefit from private sector subsidies to help with their energy retrofitting and renewable energy projects.

# **ENOPRIMES**

If you own or lease a house or apartment, why not consider using enoprimes to support your energy renovation projects?

#### Heating

- Condensing boiler:
- €500 for a house of less than 500m<sup>2</sup>
  €1,700 for a residence of less than 750m<sup>2</sup>
  €2,600 for a residence between 750m<sup>2</sup> and 3,000m<sup>2</sup>
- Heat pump:
   €2,500 for a house of less than 500m<sup>2</sup>
   €5,000 for a residence of less than 3,000m<sup>2</sup>
- Log burner (wood or pellets):
   €500 for a house of less than 500m<sup>2</sup>
   €1,700 for a residence of less than 750m<sup>2</sup>
   €2,600 for a residence between 750m<sup>2</sup> and 3,000m<sup>2</sup>

## Solar panels

- Solar thermal panels:
- €35/m² of panelling

When replacing heating installations, there is a bonus of €500 if the heating system being replaced ran off fuel and the new system uses an alternative energy source.

#### Insulation and windows

Thermal roof/loft insulation:  $€12/m^2$  of insulation installed\* Thermal insulation for external walls:  $€12/m^2$  of insulation installed\* Thermal floor insulation:  $€4/m^2$  of insulation installed\* Window replacement:  $€22/m^2$  of glazing\*

There is also a grant for installing controlled mechanical ventilation with a heat recovery system.

Important condition: you must apply for a grant from one of our partners **BEFORE signing the purchase order** for the work to be performed.
